Canvass City of Madison:

Moved by Benski, second by Willett, that the Dane County Board of Canvass (DCBC) will not include the totals from the City of Madison Board of Canvass for improperly rejected absentees due to not arriving at the correct polling location. The absentee ballots in question were not delivered to the polling places serving the elector's residences before 8 p.m. on election day as required by Wi. Stat. §6.87(6). That subsection expressly states that "any ballot not mailed or delivered as provided in this subsection may not be counted." That statute is mandatory in nature and the Board of Canvassers has determined that these ballots must not be counted. The DCBC will attempt to determine the provisional ballot totals if possible. Potentially legitimate improperly rejected absentees will also be rejected as they cannot be separated from the other ballots. Vote was 3-0

Moved by Willett, second by Benski to accept Ward 32 improperly rejected absentee due to note in inspector statement. Vote was 3-0
