THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and Service America Corporation dba Sodexo Live! (hereinafter, "Sodexo").

WITNESSETH:

WHEREAS Centerplate and County, by a separate document (hereinafter, the "Master Agreement"), Purchase of Services Agreement No. 11656, have previously entered into a contractual relationship pursuant to which Sodexo operates the food and beverage service at the Alliant Energy Center, and

WHEREAS County and Sodexo wish to amend the Master Agreement to modify some of its terms to address the financial impacts of the COVID-19 pandemic and the level of business since then on the food and beverage operations at the Alliant Energy Center,

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. Adjust the annual commission guarantee schedule under Schedule 3 for each contract year beginning June 1, 2024 and expiring June 30, 2027, per the following:
