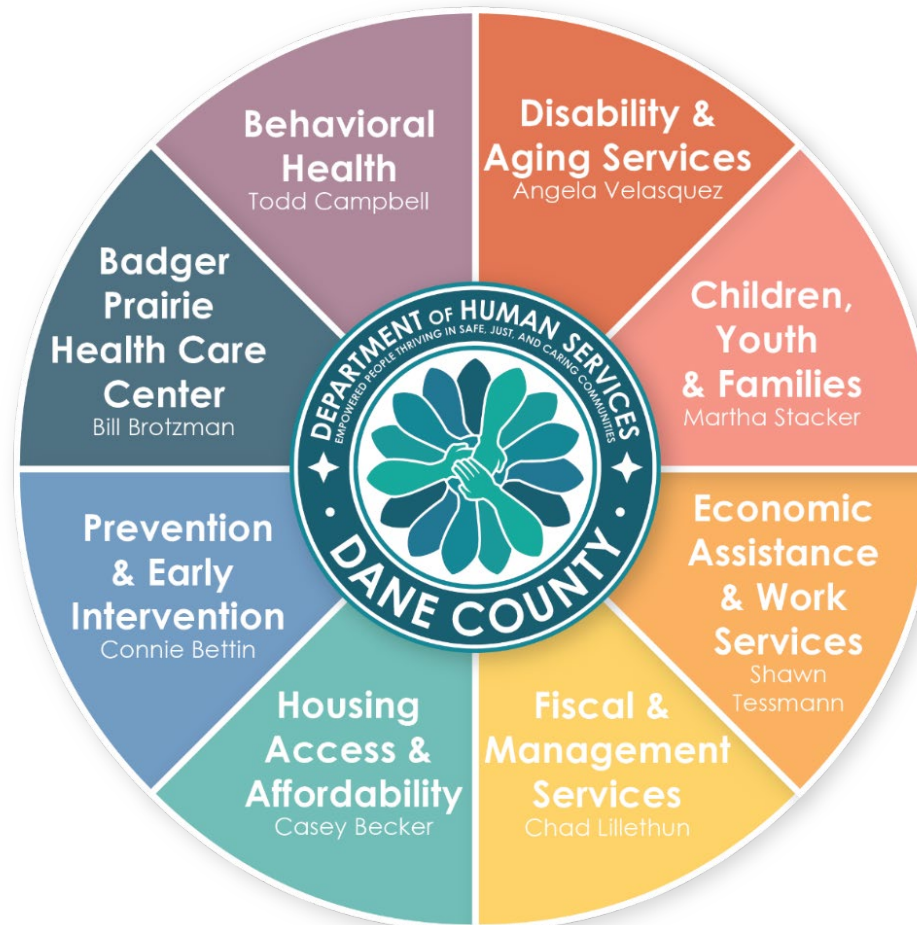

BEHAVIORAL HEALTH

Philosophy & purview:

To help people across the lifespan remain safe during a behavioral health-related crisis and to assist people in their recovery from mental illnesses and/or substance use disorders.

Statutory Obligations (§ 51.42(1)(b)):

- The county board of supervisors has the primary responsibility for the well-being, treatment and care of the mentally ill, developmentally disabled, alcoholic and other drug dependent citizens residing within its county and for ensuring that those individuals in need of such emergency services found within its county receive immediate emergency services.
- Limited to the programs, services and resources that the county board of supervisors is reasonably able to provide within the limits of available state and federal funds and of county funds required to be appropriated to match state funds.

BEHAVIORAL HEALTH

- **Urgent Care** – Crisis Services, Behavioral Health Resource Center, Peer Support
- **Recovery Management** – Residential Services, Case Management, Vocational Support
- **Justice Support and Clinical Services** – Alternative Sanctions, Substance Use Disorder Treatment, Outpatient Services, Youth Case Management
- **Comprehensive Community Services (CCS)** – Operate intake and eligibility functions, certify and manage service facilitation and array agencies
