AUTHORIZING AN AGREEMENT TO TERMINATE DANE COUNTY CONTRACT WITH GFL FOR THE OPERATION OF THE CONSTRUCTION AND DEMOLITION RECYCLING FACILITY

Policy Analysis Statement:

Brief Description of Proposal -

GFL and Dane County have agreed upon terms to terminate the contract for operating the Dane County Construction & Demolition Recycling Facility. GFL has agreed to transfer ownership of equipment and committed to delivering a minimum annual tonnage to the facility through the end of 2030.

Current Policy or Practice -

GFL Solid Waste Midwest LLC, has requested to terminate their contract, and staff feels that this is in the best interests of the County.

Impact of Adopting Proposal -

Terminating the GFL contract would allow Pellitteri Waste Systems to operate the Dane County Construction & Demolition Recycling Facility, enabling the County to offer recycling services to residents and businesses and conserve landfill airspace.

Termination is contingent on GFL's commitment to deliver a minimum annual tonnage of materials to Dane County through the end of 2030. The approximate value of this material is \$1.26 million annually. If GFL fails to deliver this material, they remain responsible to compensate Dane County the full value of any shortfall.
