Please see below for descriptions of the OT lines in the report I sent last week.

OT FLEX-LANE BELTLINE	This was an OT line used for the Flex Lane patrol, when the Flex Lane on the Beltline was created. We no longer use this line.
OT-PROJECT SAFE NEIGHBORHOOD	This is a grant that is used by the Dane County Narcotics Task Force. The grant has been awarded several years in a row. Unknown if we will be getting this award again. This is reimbursed through grant funding.
OVERTIME	Needed for Overtime. ??
OVERTIME - LE ACADEMY	This is for Overtime at the Training Center re: Law Enforcement Academy related.
OVERTIME-BIKE SAFETY PROGRAM	This was a grant, we have not had this grant in a number of years. We no longer use this line.

OVERTIME -DCNTF HEROIN INITIAT	If this is for SHRFFLD 10040, that is a grant that was awarded and OT was worked in the past. This is reimbursed through grant funding.
OVERTIME-BOAT PATROL	This is for the Boat Patrol overtime when patrolling the lakes and responding to distress calls. This is offset partially by the DNR
OVERTIME-COLISEUM	This is the OT that is worked for security at the Coliseum.
OVERTIME-DCNTF METH INITIATIVE	This is a grant that is used by the Dane County Narcotics Task Force. The grant has been awarded several years in a row. This is reimbursed through grant funding.
OVERTIME-HIDTA GRANT	This is a grant that is used by the Dane County Narcotics Task Force. The grant has been awarded several years in a row. This is reimbursed through grant funding.
OVERTIME-INTER-AGENCY	This is overtime for our contract Police deputies.
OVERTIME-RURAL SAFETY BELT	This is a grant for Seatbelt enforcement, and is usually issued annually. This is reimbursed through grant funding.
OVERTIME-SATURATION/BLNKT PTRL	This is a grant for Alcohol/Impaired Driver enforcement, and is usually issued annually. This is reimbursed through grant funding.
OVERTIME-SERVICE PATROL	This is OT for patrol by the Freeway Services Team (yellow truck) on the beltline. There is some reimbursement from the state for these expenses.
OVERTIME-SPEEDWAVES	This is a grant for Speed enforcement, and is usually issued annually. This is reimbursed through grant funding.
