

ADDENDUM # 15992A

Revised 11/2024

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and R.H. Batterman & Co Inc. (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract # 15992, have previously entered into a contractual relationship pursuant to which Provider provides design services on CTH MM from McCoy Rd to USH 12/18, and

WHEREAS County and Provider wish to amend the Master Agreement in order to provide additional work beyond the original agreement amount including additional coordination for hazardous materials, traffic analysis for design of traffic signals, comprehensive staging and traffic control plans and further coordination with WisDOT, utility companies and other involved agencies in order to complete the final plans, specifications and estimates on an expedited timeline.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.

3. Schedule A - Scope of Work is revised to include the following additional work items that will be completed to meet the updated February 9, 2026 PS&E deadline at an additional cost of \$193,600:
 1. Address preliminary design comments from WisDOT and resubmit
 2. Update Design Study Report (DSR) based on additional feedback from WisDOT
 3. Add Encroachment Report
 4. 90% Transportation Management Plan (TMP)
 5. Full design of two traffic signals (permanent and temp)
 6. Proprietary Product Justification (PPJ) preparation for signal cabinets
 7. Additional Traffic analysis based on full design of two traffic signals (permanent and temp)
 8. Additional coordination with City of Madison for signal design
 9. Additional HazMat Phase 2.5 coordination at three (3) locations along the corridor
 10. Additional staging and traffic control plans due to additional signal design work
 11. Additional coordination with Madison Metro for bus accommodations during construction
 12. 90%/final plans
 13. Up to five (5) FIIPS funding categories
 14. PS&E documentation
 15. Utility coordination (additional utility companies identified)
 16. Special provisions (additional specials required due to signals and other coordination items)
 17. Additional agency coordination
 18. Final PS&E delivery in ASSHTOWare with additional funding categories
