The survey will be a pilot project to learn from people with lived experience of criminal justice system involvement and their families about their experience navigating the behavioral healthcare system during incarceration and beyond release to identify gaps and barriers. Previous work by the subcommittee has used the agencies' perspectives to identify gaps and barriers, and this initiative aims to incorporate the voices of people with lived experience. Presenters discuss scope, methods, survey questions, and next steps.

Discussion ensues. Subcommittee members make recommendations on revisions to survey questions. Discussion of recruitment strategies, community engagement, and dissemination methods. Discussion of methods and anticipated response rates. Subcommittee members are interested in moving forward with survey, with minor revisions.

Motion made by Oman, seconded by Shimko to recommend for approval the lived experience survey, once finalized, to the CJC. The motion carried by a voice vote.

Presentation regarding initiatives to support incompetent to stand trial population. Meetings with stakeholders in criminal justice system and human services to address issue. Presentation regarding lack of resources to support people after competency restoration, lack of hospital beds and waitlist times, and barriers to community-based competency restoration in Dane County. Discussion regarding diversion prior to initial appearance and booking alert for people with past Chapter 51 commitments. Discussion of opportunities through mental health court for high-risk, high-needs defendants.

### 2. Update on the Crisis Triage Center

The RFP for a provider for the Crisis Triage Center did not receive any bids. This is due to statutory and regulatory hurdles in Wisconsin, due to the center being a non-hospital center that takes involuntary commitments. There are also challenges with sustainable funding and billing.
