ADDENDUM # 14789A

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and BIOFerm Energy Systems, LLC (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract #14789, have previously entered into a contractual relationship pursuant to which Provider provided engineering support, and

WHEREAS County and Provider wish to amend the Master Agreement in order to extend the contract amount by \$175,000, and

WHEREAS, pursuant to Section III of the Master Agreement, Provider wishes to assign all of its rights, obligations, and interests under the Master Agreement to BIOFerm EPC, LLC, its affiliate, and County consents to such assignment, and

WHEREAS, County and Provider agree that, as of September 1, 2025, all references in the Master Agreement to "Provider" shall be deemed to refer to BIOFerm EPC, LLC.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
- 3. The additional cost of the contract is extended by \$175,000.

4. Effective as of September 1, 2025, Provider hereby assigns to BIOFerm EPC, LLC all of its rights, duties, obligations, and interests under the Master Agreement. From and after September 1, 2025, BIOFerm EPC, LLC shall be deemed the "Provider" for all purposes under the Master Agreement, and shall assume, perform, and be responsible for all obligations and liabilities of Provider. County hereby releases and discharges BIOFerm Energy Systems, LLC from any and all liabilities, obligations, claims, or causes of action arising under or related to the Master Agreement from and after September 1, 2025. For clarity, this release does not affect any liabilities incurred or claims made by BIOFerm Energy Systems, LLC prior to September 1, 2025.
