C. Discussion Items

Ethics Training

The training was presented to the Subcommittee.

EMS Protocols

MEP and UW Consortium provided updates on EMS protocols update process. MEP's are live, UW roll-out date aiming for July 1st. Will have updated training sheets for agencies with implementation.

DCEMS Office Update

Annual survey being finalized to go out. Eric Anderson is working on getting CARES report data out to agencies. Anderson is also looking into Imagetrend vs ESO for EMS run reporting; currently leaning towards ESO. R31 is in service. R30 bariatric ramp is not currently functional and office is looking into repairs for that. PulsePoint Professional Responder has been updated to allow all approved responders to respond in all of the county, including City of Madison. Johnston is also pushing to get all Professional Responders alertable with CPR alerts and location settings.

E. Reports to Committee

Public Health MDC - Van Horn gave an update on measles and ebola. No new cases of measles in Dane County or Wisconsin since February 2026. Big outbreak of ebola in Uganda and Democratic Republic of Congo. This strain cannot be treated or vaccinated against with current treatments. PHMDC is monitoring 3 returned travelers with low-risk likelihood of having contracted the virus. PHMDC will continue to be contacted and following up on travelers as they return from traveling to these countries. Working on a protocol that will not delay emergency care to ebola patients, but will also give adequate notification to EMS Providers and hospitals so they can prepare to safely treat these patients.
