1 LIO 2026 Budget Request for submittal to the County Executive

MUELLER presented the 2026 Land Information Office (LIO) budget to the Council. There was a discussion on software licensing and that the LIO would cover the cost for 2026 but that in the future other sources of funding will be needed.

1 Legislative Updates: JPA Trailer & RETF

IAUSLY provided an update on the Judicial Privacy Act (JPA) Trailer legislation that it was passed by both houses of the legislature and now waiting for the Governor's signature. Unclear when that will happen. For the Real Estate Transfer Fee (RETF), the WLIA is working with the WI Counties Association (WRA), WI Realtors Association (WRA) and legislators to introduce a bill that looks to lower the real estate transfer fee from \$3 to \$2, split the revenue 50/50 between the state and counties and provide funding for the WI Land Information Program. IAUSLY stated that it was unclear on the timeline for this.
