AUTHORIZING AN AGREEMENT TO TERMINATE DANE COUNTY CONTRACT NO. 12204
WITH GFL SOLID WASTE MIDWEST LLC FOR THE OPERATION OF THE CONSTRUCTION
AND DEMOLITION RECYCLING FACILITY

Dane County owns and operates the Dane County Construction and Demolition Recycling Facility (the "Facility"), which recovers construction and demolition ("C&D") materials and supports the County's waste diversion goals; and

WHEREAS, the County and GFL Solid Waste Midwest LLC ("GFL") are parties to a General Service Agreement for C&D waste recycling services (Dane County Contract No. 12204) together with a Construction and Demolition Recycling Facility Ground Lease and a Construction and Demolition Waste Recycling Facility Equipment Lease (collectively, the "Agreements"), which govern operation of the Facility; and;

WHEREAS, GFL was assigned the Agreements (Dane County Contract No. 12204C) and assumed all rights and obligations arising thereunder, with the Agreements scheduled to expire December 31, 2030; and

WHEREAS, GFL has expressed its desire to terminate the Agreements prior to their scheduled expiration, and the County intends to transition operation of the Facility to another qualified operator to ensure continued C&D recycling service; and

WHEREAS, the County and GFL have negotiated an Agreement to Terminate Dane County Contract No. 12204 (the "Termination Agreement") that protects the County's operational and financial interests; and

NOW, THEREFORE BE IT RESOLVED that the County Executive and the County Clerk be authorized and directed to sign the Termination Agreement; and,

BE IT FINALLY RESOLVED that the Department of Waste + Renewables be directed to ensure complete performance of the Termination Agreement.

AGREEMENT TO TERMINATE DANE COUNTY CONTRACT NO. 12204
CONFIDENTIAL

Dane County ("County") and GFL Solid Waste Midwest LLC ("GFL") are parties a General Service Agreement for construction and demolition waste recycling services (Dane County Contract No. 12204) dated December 2, 2014, as amended on November 11, 2020, a Construction and Demolition Recycling Facility Ground Lease and Construction and Demolition Waste Recycling Facility Equipment Lease ("the Agreements") together governing the operation of the Dane County Construction and Demolition Recycling Facility (the "Facility").

GFL Solid Waste Midwest LLC ("GFL") was assigned the Agreement, the Ground Lease, and the Equipment Lease on July 21, 2025, and thereby assumed all rights and obligations arising thereunder. The Agreements expire December 31, 2030. GFL has expressed its desire to terminate the Agreement prior to its scheduled expiration.

For good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree to terminate the Agreements subject to the terms and conditions set forth below.

1. Minimum Annual Tonnage

GFL shall guarantee delivery to the Facility of the Total Minimum Annual Tonnages of construction and demolition ("C&D") material and mixed waste set forth in Table 1 below. This obligation shall remain in effect through at least the end of calendar year 2030. Total Minimum Annual Tonnages shall be calculated by the County on a calendar-year basis, from January 1 through December 31.

⁽¹⁾ Mixed Waste is inclusive of all landfilled material (contaminated soil, special wastes, etc.). Minimum tonnage requirement for Mixed Waste does not include C&D fines or C&D Residuals.

⁽²⁾ C&D tonnage shall consist of loads of co-mingled, acceptable materials, comprising not less than fifty percent (50%) recyclable wood, metal, cardboard, or aggregate, delivered to and accepted at the Facility.

2. Shortfall Fee

If, at the end of any calendar year during the Term, the County determines that GFL has delivered less than the applicable Minimum Annual Tonnage, GFL shall pay the County a shortfall fee equal to the large hauler material rate as established by Dane County Ordinance for each ton by which the delivered tonnage falls below the Minimum Annual Tonnage.

3. Transfer of Equipment and Material

GFL shall convey and transfer to the County, and the County shall acquire, all right, title, and interest in and to at least the following equipment and material, free and clear of all liens, security interests, and encumbrances:

- Toyota Forklift Truck, Model Number: 8FGU30, Serial Number: 71233
- Bobcat Skid Steer, Model Number: S70, Product ID Number: B5Y212170
- Skyjack man lift, Model Number: SJ4632, Serial Number: 70003935
- Cumberland Engineering Vinyl Granulator, Model Number: 1628X, Serial Number: CA083400-13001
- Fire Rover fire suppression system
- Storage containers
- Spare parts and tools
- Lawn mower
- Portable misting device
- Job trailer
- Semi ramp
- New and unused personal protective equipment (PPE)

4. Removal of Property from the Premises

GFL shall, at its sole cost and expense, remove from the Facility premises all equipment and material not desired by the County, including the following:

- All equipment currently stored in the wood yard;
- All non-functional equipment, tools, and materials; and
- All technology, files, and information containing sensitive employee information.

5. Termination Timeline

GFL shall conclude operations of the Facility on the following timeline:

- August 19, 2026: Stop acceptance of inbound materials at facility two allow for clearing of all materials
- August 31, 2026: Vacate premises including:
 - Complete removal of all material accepted at the Facility prior to August 19, 2026.
 - Removal of Property as detailed in Section 4.
 - Removal of all materials and debris from facility, including sorting equipment, electrical room, control room, and sorting room.
 - Facility to be left in broom-swept condition with reasonable measures taken to remove excess dust from surfaces, rolling stock, and sorting equipment.
- The quarterly equipment lease fees owed by GFL to the County shall be prorated to reflect the termination of the Agreement on August 31, 2026.

6. Safety

GFL staff and drivers must follow safety rules of the facility, including abiding by speed limits.

7. Term

This Agreement shall terminate on December 31, 2030.
