F. Discussion Item

Chair Andrae invited members to suggest committee priorities. Supervisor Collins suggested topics related to juveniles interacting with the criminal justice system. Supervisor Rose suggested topics related to prevention efforts targeted at juveniles. Supervisor Peterson suggested discussing the issue of car thefts and human trafficking. Supervisor Weigand echoed Supervisor Peterson's suggested topic. Supervisor Rose also raised the county's efforts in the "war" on drugs as a suggested topic. Supervisor Gray suggested alternatives to incarceration and the community court, addressing the issue of transfer of residents to other jails, and issues related to cannabis legalization. Supervisor Kigeya suggested alternatives to youth incarceration as a topic. Chair Andrae suggested that the committee should prioritize the reconfiguration of the Huber program in Dane County. Chair Andrae also suggested prioritizing issues related to mobile response to crisis events, and an update on birth cost recovery expungement efforts. Supervisor Weigand also suggested that policies related to the license plate reading system should be reviewed.
