Fourth Addendum to Employment Services Agreement

This fourth addendum, made and entered into by and between the County of Dane (hereinafter referred to as "EMPLOYER") and John Bauman (hereinafter, "EMPLOYEE"),

WITNESSETH:

WHEREAS, the EMPLOYER and the EMPLOYEE have by a separate document entitled Employment Services Agreement (hereinafter the "Original Agreement") previously entered into a contractual relationship, and

WHEREAS, the EMPLOYER and the EMPLOYEE entered into an Addendum to Agreement ("First Addendum") which extended the Original Agreement for five years ending April 27, 2018, and

WHEREAS, the EMPLOYER and the EMPLOYEE entered into a Second Addendum to the Agreement ("Second Addendum") which extended the Original Agreement for one year ending April 27, 2019.

WHEREAS, the EMPLOYER and the EMPLOYEE entered into a Third Addendum to the Agreement ("Third Addendum") which extended the Original Agreement for five years ending on April 27, 2024.

WHEREAS, the EMPLOYER and the EMPLOYEE now wish to extend the term of the Original Agreement for one year commencing at the expiration of the Third Addendum at 11:59 p.m. on April 27, 2024 and ending at 11:59 on April 27, 2025.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Original Agreement, the First Addendum, the Second Addendum, and the Third Addendum shall remain in full force and effect unchanged in any manner by this Fourth Addendum to Employment Services Agreement except for those changes expressly set forth herein. This Fourth Addendum to Employment Services Agreement shall control only to the extent of any conflict between the terms of the Original Agreement, the First Addendum, the Second Addendum, the Third Addendum, and this Fourth Addendum to Employment Services.
- 2. Paragraph 6 of the Original Agreement is amended to provide that the term of agreement shall expire at 11:59 p.m. on April 27, 2025.
- 3. Paragraph 14 of the Original Agreement is amended to provide that the direct compensation paid to the EMPLOYEE shall be at a rate equivalent to \$172,411.20 per year (\$82.89 per hour). Over the course of this agreement, EMPLOYEE's wage shall also be modified to reflect any cost-of-living adjustments at the same rate and at the same time as granted to unrepresented managerial employees.

IN WITNESS WHEREOF, EMPLOYER and EMPLOYEE have executed this Fourth Addendum to Employment Services Agreement effective as of the day and date by which EMPLOYER's authorized representative and EMPLOYEE have affixed their respective signatures, as indicated below:
