C. Discussion Items

Annual CARES Report

The Cardiac Arrest Registry to Enhance Survival (CARES) data was released for 2024 incidents. Anderson shared highlights of that data in regards to Dane County's survival rate and how metrics compare to the state and the nation. Dane County continues to significantly exceed the survival rates seen at the state and national level.

Continuum Demo

Anderson showed high level use of Continuum for filtering and displaying EMS data. This is available to Chiefs and Medical Directors at EMS agencies that use Dane Elite for patient care reports.

LUCAS Application for Traumatic Arrest

May meeting discussed use of LUCAS device for traumatic cardiac arrest with interest in learning more for a better educated recommendation. There is an future conversation to be had about whether to provide compressions at all for a traumatic arrest, but for now recommendation is to only use mechanical CPR if it is needed to keep providers safe during transport. Anderson shared data that showed Dane County providers are consistently deploying the LUCAS in under 30 seconds.

EMS Protocols

DCEMS Office and Medical Advisors are looking into possibility of blood products being used by EMS providers. Initial data pull showed that in the last year there was a significant enough number of patients that would have benefited from blood to make the initiative worth pursuing. Chiefs from paramedic-level agencies are asked to reach out to DCEMS office if they are interested in carrying blood products and would like to participate in preliminary logistics planning.

DCEMS Update

There are several SRP/SRM training dates coming up in June - info will go out to Chiefs again as a reminder. EMS Annual Survey was sent out with a deadline of June 13th. R30 is out of service until further notice while the lift ramp is being fixed.

SCRTAC has received pediatric training equipment that can be reserved by agencies to train with. Stoughton Health just opened an outpatient clinic by the hospital with the same address as the ED. Providers have been notified of this in case they are called to the clinic for a patient. Soon there will be road construction that affects access to both the hospital and the clinic; notice will be sent to all agencies once Stoughton Fire and EMS Chiefs have been notified.
