3 AMENDING CHAPTER 41 OF THE DANE COUNTY CODE OF ORDINANCES,
4 REGARDING SOLID WASTE DISPOSAL USER FEES
5

6 The County Board of Supervisors of the County of Dane does ordain as follows:
7

8 ARTICLE 1. Unless otherwise expressly stated herein, all references to section
9 and chapter numbers are to those of the Dane County Code of Ordinances.

11 ARTICLE 2. Section 41.115 is amended to read as follows:

12 **41.115 USER FEE SCHEDULE.**

13 (1) The standard fees for allowable solid wastes at Landfill No. 2 (Rodefild), for which
14 no special fee has been established, shall be assessed at a rate of \$4443.00 per ton of
15 material deposited, plus all applicable State imposed fees.

16 (2) Special fees for asbestos and mixed shingles at Landfill No. 2 shall be \$5759.00
17 plus all applicable fees. Materials that require special handling or waste profiling may be
18 charged additional fees based upon actual costs to the Department not to exceed
19 \$200.00.

20 (3) The standard fees for deposit of allowable materials at Landfill No. 2 or the
21 Construction and Demolition Recycling Facility shall be assessed at the following rates:

23 Construction and Demolition	<u>\$5456.00</u>
24 For Recycling	
25 Tires	<u>\$275320.00</u>
26 Clean logs, branches & brush	<u>\$40.00</u>
27 Clean wood chips	<u>\$25.00</u>
28 Asphalt Shingles	<u>\$5456.00</u>

31 (4) Loads of waste deposited at Landfill No. 2 or the Construction and Demolition
32 Recycling Facility weighing less than 1 ton (2,000 pounds) shall be assessed a prorated
33 flat fee at the following rates:

<u>Load Deposited</u>	<u>(% of per</u>
	<u>ton rate)</u>
35 Less than 500 lbs.	25%
36 500 lbs. but less than 1,000 lbs.	50%
37 1,000 lbs. but less than 1,500 lbs.	75%
38 1,500 lbs. but less than 2,000 lbs.	100%

43 (5) Notwithstanding the rate set forth in subs. (1) & (3), the rate for high volume users
44 shall be \$3739.00 per ton, plus all applicable state imposed fees for solid wastes
45 deposited at Landfill No. 2. This rate does not apply to landfilled solid wastes with
46 special fees.

47 (6) Notwithstanding the rate set forth in subs. (1) & (3), the rate for high volume users
48 shall be \$5254.00 per ton, plus all applicable state imposed fees, for construction and
49 demolition debris deposited at the Construction and Demolition Recycling Facility.

50 (7) As used in subs. (5) & (6), *high volume user* means an entity that has deposited at
51 least 500 tons of waste or recyclables at the site in each of the 6 months immediately
52 preceding the month in which this subsection is applied.

53 (8) The standard fees for deposit of allowable wastes as Clean Sweep shall be
54 assessed according to the following schedule:

<u>Customer Type</u>	<u>Fee</u>
57 Dane County Households 58 & Farms	\$15.00 per trip
59 Businesses	Fee based on 60 weight and 61 type of waste
62 Out-of-County Households 63 & Farms	\$75.00 per trip

65 The fee for Households and Farms is for disposal of all household hazardous waste and
66 miscellaneous electronics in a single residential or farm load. Dane County reserves the
67 right to charge additional fees for excessive sized loads. An additional fee will be
68 charged for disposal of certain electronic devices as follows:

70 Microwave Oven	\$10.00
71 Television or Computer Monitor	\$15.00

73 (9) The committee may recommend to the County Board, and the County Board may
74 approve contracts with individual customers that guarantees specific waste volumes to a
75 landfill for a set period of time for disposal rates that are lower than those set forth in sub
76 (1).
