## Initializing the Office of Justice Reform

- Creation: Budget 2023
- "Through a combination of new staff positions and realigning existing capacity, this new department will be a dedicated, independent resource to bridge agencies within the criminal justice system and lead Dane County's next steps on data driven reforms. The budget includes funds for the agency to administer a microgrant program to support community-based reforms."
- This budget also allocates \$85,000 for a new re-entry partnership with Dane County and Project Big Step to help those leaving jail with job training that can lead to careers in the trades.

The source for inclusive and transformational adult justice system improvements using:

- collaboration (stakeholders, community, researchers)
- data driven decisions
- innovation and catalyst funds




Engage and invest in strategies to

improve racial equity in Dane County's justice system.

#### Specific Overall Objectives---initializing in 2024-2025

Improve health outcomes for familiar faces Increase racial, ethnic, and gender equity in the criminal justice system of Dane County Engage with community to seek input and partnership on justice improvement strategies

CJC Executive and subcommittee reengagement Save county dollars on long term safe and equitable justice strategies

### Potential forward movement

- Create pathway for interns- $\rightarrow$ research fellows.
  - LTE's can help support minutes, agendas, and coordination of CJC subcommittees
- Catalyst department for gathering national "better" practices and collaborating cross agencies and community to increase fairness and justice throughout Dane County.
  - Boundary spanning role for overall County justice fairness goals (strategic plan).
- Develop strategic engagement specialist (grant funded) position description requesting an individual with lived experience in the criminal justice system.
  - Community court grant funded; liaison to communities most impacted by criminal justice.
- Collaborate and win grants that impact overall criminal justice outcomes with a racial equity lens.
  - Catalyst funds for proof of concept; local and national partnerships
- Develop with data owners internal stakeholder dashboards.

## Immediate next steps

- ▶ 1. Develop 2025 Budget
- ► 2. Hire staff
- Comply with all federal requirements for the BJA Community Court grant (train additional staff in BJA specific performance reports)
- ▶ 4. Negotiate and execute Big Step contract
- ▶ 5. Re-engage the CJC of Dane County
- ▶ 6. Develop process for strategic plan development
- ▶ 7. Meet with community, City and County stakeholders
