Culturally significant resources have been noted on the hilltop of this portion of the property. The purchase of this property would ensure future preservation of these resources. |
| 18 19 20 21 22 23 | The adjacent 2 acres to the east is a residential lot containing a 1,400 square foot house that the owner uses during the growing season. LWRD plans on carving the house off the property and offering it for sale. The remaining approximate 1 acre across the street sits on the Yahara River and contains a small storage building. It is mostly wetland and will provide opportunities for lake management. |
| 23 24 25 26 27 28 | The Darst's have agreed to a purchase price of \$1,400,000 for the property and will lease the property back at no cost through August 2028. This occupancy period will give the seller time to close down business operations and remove all of the plantings and equipment. |
| 29 30 31 | Funds for the purchase are available in the 2025 Dane County Conservation Fund budget. The debt issued to support this expenditure will have a term of 20 years. |
