Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Sheriff's Office participates in a High Intensity Drug Trafficking Area (HIDTA) Program as part of the Milwau kee HIDTA and operates as a member agency for the program. Request authorization to accept grant funding from the Office of National Drug Control Policy (ONDCP) to support the HIDTA Program.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

Acceptance of grant funds from ONDCP shall provide reimbursement for criminal investigations involving drug trafficking and money laundering organizations to reduce drug trafficking and drug production in the region. Enhanced intelligence processes and greater operational coordination and prosecution reduces organized drug distribution, drug related violent crime, money laundering, and the demand for illegal drugs within the Milwaukee HIDTA region and decrease the distribution of illegal drugs to Wisconsin urban and rural areas.
