# Isolation/Quarantine Center (IQC)

- ▶ Daily Average: 11 guests
- ▶ April high: 23 (03/19/23, 3/20/23)
  - ▶ April 14, May 46, June 39, July 57, Aug 38, Sept 33, Oct 18, Nov 30, Dec 1, Jan 20, Feb 12, March 19-20,
- ▶ April low: 0 (04/14/23-04/19/23)
  - ▶ April 7, May 4, June 16, July 20, Aug 5, Sept 3, Oct 2, Nov 3, Dec 26, Jan 6, Feb 4, March 13

\*\*\* Program sunset on April 30<sup>th</sup>, 2023. Working closely with Public Health and shelters on COVID mitigation strategies in congregate settings.



# Hotels to Housing (H2H)

As of 04/30/23

- ❑ 214 households currently enrolled
  - 179 currently housed (92 LSS, 46 TSA, 41 ESS)
  - 35 searching for housing (27 singles & 8 families)
    - ❖ *Names for single individuals have started to be taken from Coordinated Entry. Two of the providers will still newly enroll about 20 more households who will be placed into housing.*
- ❑ 260 housed to date
  - 61 housed exits (EHV, deceased, assisted living, assistance ending, etc.)
  - 34 non-renewed - average 13.1% (17 rehoused, 13 have left & are searching, & 4 exits)
- ❑ 81 housed households have assistance ending between July-Dec 2023 (24 months expires)
- ❑ 57 EHV referrals (24 LSS, 18 TSA, 15 ESS)
  - 26 of those referrals are those with assistance expiring by end of this year; there are limited spots.
  - Approximately 40 households are in process of application approval, briefings, and/or issuance)

NOTE: Goal: 297 households. To date: 331 households. Housing placement average 78.5%.



# CORE 2.0

- ▶ On May 31, 2023 at 11:59 p.m. Dane CORE 2.0 will close
- ▶ The receipt of an application is not a guarantee that an applicant will receive funds, however, providers will continue to process applications and make payments as funding allows.
- ▶ Applications will continue to be processed in the order they are received.
- ▶ Anyone in need of funding is encouraged to apply as soon as possible.
- ▶ Anyone who has an application pending or has previously submitted through the portal **should not** submit a new application, but should request an additional funding request be opened instead, by emailing the processing agency.
- ▶ Once the portal closes, an applicant will still be able to check the status of their application.   - ▶ Eviction Prevention Coordinated Entry (CE) is the first phone number people should call if they are being evicted from their home in Dane County.
  - ▶ Through this intake system, Eviction Prevention CE staff will determine eligibility for assistance from several participating organizations.
  - ▶ If a person qualifies for eviction prevention services, this intake system allows them to access assistance from several organizations with only one phone call.
  - ▶ Eviction Prevention CE services may include financial assistance, information about tenants' rights, mediation, referrals to a lawyer through Legal Action of Wisconsin, and short-term housing case management.

# Doubled Up Households RFP

- ▶ RFP submission deadline closed on April 4, 2023 with three submissions.
- ▶ Expected to award up to \$1.2M in service provisions for housing placement support which includes navigation, direct payment assistance, and on going case management.
- ▶ Award includes funding support for case management positions.
- ▶ Operations estimated to commence by September 1, 2023.
- ▶ Program will support households through September 30, 2025.



# DCDHS has posted the following RFPs:

## ▶ 424010-HKD Rapid Re-Housing Services

The Dane County Department of Human Services' (DCDHS), Division of Housing Access and Affordability (HAA) seeks partners to provide case management and direct assistance for Rapid Re-Housing (RRH) services. The program is designed to assist people experiencing homelessness with housing search, moving into permanent housing, and working towards long-term housing stability with intensive case management services.

## ▶ 424011-HJW Housing Navigation Services

The Dane County Department of Human Services' (DCDHS), Division of Housing Access and Affordability (HAA) is requesting proposals for Housing Navigation services. Housing navigation services are defined generally as assisting individuals in need of housing, including but not limited to help with a housing search; identification of an individual's housing barriers; guidance and advocacy to overcome those barriers; information and referral to community resources to address concerns related to housing (employment and training, mainstream benefits, etc.), and assistance in filling out housing applications.

# American Rescue Plan (ARP) funded programs wind down timeline

- ▶ **Isolation and Quarantine Center Hotel** – Program sunsets on April 30<sup>th</sup>, 2023. Last day for referrals is April 17<sup>th</sup>, 2023.
- ▶ **Dane CORE Emergency Rental Assistance** – No new applications after May 31<sup>st</sup>, 2023. Applications will be processed as funds remain after portal closure.
- ▶ **Outreach Services through Catalyst for Change** – Funding/contract currently ends December 31<sup>st</sup>, 2024.
- ▶ **Hotels to Housing** – Program ends in October of 2024 and current clients will exit throughout 2023 and 2024 as they reach their 24 months maximum of assistance (Kristina, I know this is a bit of a moving target, please jump in to correct me if needed).
- ▶ **Eviction Defense and Diversion Program (EDDP)** – Funding currently through 2024, priority to extend with additional ERA funds, if possible.
- ▶ **Doubled-Up Housing Pilot** – Funding through September of 2025 (per federal regulations)
