RE: Violation of conditions under Conditional Use Permit #2610

Dear Mr. Niebuhr,

On March 12, 2024, the Dane County Zoning and Land Regulation Committee approved Conditional Use Permit #2610 for Transient and Tourist Lodging for the property located at 3160 County Hwy J in the Town of Springdale. The conditional use permit was issued with a limitations of the number of persons for rental along with a host of other conditions. Specifically, Condition #17 states that "The transient or tourist lodging shall have a maximum of 8 people on the premises at any time."

The Dane County Zoning Division has been informed that the transient and tourist lodging facility is being advertised for short-term rental for 10 to 14 persons. This advertisement is in direct violation of the conditions of Conditional Use Permit #2610.

Under Dane County Code of Ordinances Section 10.101(7)(d)2.a.xiv., "*Failure to comply with any imposed conditions, may be grounds for revocation of the conditional use permit. The holder of a conditional use permit shall be given a reasonable opportunity to correct any violations prior to revocation.*"

Notice is hereby given that this matter will be before the Dane County Zoning and Land Regulation Committee (ZLR) on March 26, 2024 regarding violations of the conditional use permit conditions. The Committee will discuss the violations and possible revocation of Conditional Use Permit #2610.

The ZLR Committee meeting will be held remotely using the ZOOM meeting app as well as in person. The meeting will start at 6:30pm. To attend the meeting:


