Fly Dane 2024 and Impacts on the 2024 Budget - lausly & Mueller

Dane County last conducted a Lidar project in 2017. A group of counties are planning to apply for funding to pay for Lidar in 2024 to achieve Quality Level 1 product. The 2024 Lidar projects will be the most accurate countywide datasets in Wisconsin due to improved technology and new specifications. Dane County's portion for this Fly Dane Terrain Project will be \$137,940. Although this project has already been approved, the LIC is asked for their approval as well.
