This bid waiver is being submitted to obtain approval to maintain our current Victim Information and Notification Everyday (VINE) automated notification system designed to provide crime victims and families up-to-date offender information. VINE allows victims of crime to use the telephone or the Internet to search for information regarding their offender's custody status and register to receive telephone or e-mail notification when their offender's custody status changes. VINE notifications are one way crime victims, or the general public, can stay informed about the custody location and custody status of an offender, 24-hours a day, 7-days a week. Crime victims and concerned citizens can register to be notified by phone, email, text message (SMS) or TTY device when an offender's custody status changes. Users can also register through a toll-free number. This notification service is provided at no cost to the user.

VINE notification service is currently directly reimbursed through the resident phone provider contract. Resident technology service is currently under contract until May 3, 2025. The Sheriff's Office requests authorization to reimburse Appriss VINE directly for the automated notification system and when the resident phone and video visitation contract is executed the resident technology vendor shall reimburse the Sheriff's Office monthly for the notification service.
