Fifty-seven participating cities, counties, and states across the country are doing the on-the-ground work of reimagining and rebuilding local justice systems.

- With grants from The John D. and Catherine T. MacArthur Foundation's Safety and Justice Challenge, the Network is implementing a wide variety of strategies all aimed at reducing jail populations and eliminating racial and ethnic disparities. These tactics and successes can be used as models for similar reforms across the country.
- Some of the cities and counties within the Safety and Justice Challenge received a grant through the Challenge Innovation Fund. These jurisdictions receive funding, technical assistance, and ongoing access to resources and peer learning opportunities.

Tap In Center in St. Louis County

A community-based space for justice-involved individuals to "tap in" to legal assistance and community supports without fear of arrest.

The Problem

- Amissed court date typically results in a bench warrant, regardless of the reason.
- COMD-19 exacerbated existing barriers to attending court dates.
- Defendants have little recourse to resolve this issue in a way that does not result in arrest.

ACommunity-Focused Solution

The location, time of day, and program structure was informed by our community partners. Specific branch locations were chosen based on a datadriven assessment of community needs.

Program Model

When & Where?

The Tap In Center operates from 6-8 pm every Tuesday at a library branch.

What?

The hallmark service is facilitating a <u>warrant recall</u> for warrants <u>issued due to missing a court appearance</u> on a felony or misdemeanor case.

How?

Race

A defense attorney speaks with a prosecutor to advocate for the participant's warrant to be recalled.
New court date is set if the prosecutor agrees.
Case manager provides court reminders, transportation to court, and other supports.

700+ Warrants Recalled

- 86% of requested warrant recalls on felonv cases were granted.
- 96% of requested warrant recalls on misdemeanor cases were granted.
- 86% of participants who had a warrant recaller have not returned to jail.

"...It's honestly unheard of. Usually your whole family has to put money down to get you a paid lawyer to resolve something like this. I was at the point of trying to turn myself in when I got the information about this program." -TICParticipant The St. Louis American (Nov.9, 2020)
