# **Friends of Dane County Parks Grant Programs**



2023 Grant Program Details

The Friends Capital Grant Program was created in the 2020 County Budget and provides matching funds to Friends groups and other nonprofit organizations to implement capital improvements on Dane County parkland. There are two grant options for Friend and Partner organizations.

Capital Grants will fund up to 75% of the total project costs and can range from \$2,000 - \$18,750. All grants must be matched 25% with cash.

In the 2023 budget, funding from the Environmental Council's Community Partners grant program was transferred to Dane County Parks. Mini Grants can fund a full or partial project/program between \$250-\$2,000.

The 2023 grant period opened February 1 and had an initial review after March 15, 2023. The program was advertised with a rolling deadline after the initial application period if there was still funding available. Capital Grants will remain open. Mini Grants will close after these initial grant awards.

# **Capital Grant**

Grants will be awarded for capital projects on county parkland. Capital improvements are defined as permanent changes that have a life expectancy of at least ten years. Projects must be far along in the planning process and meet the following minimum eligibility requirements to be considered for funding:

- Total project cost may not exceed \$25,000 for projects that involve construction or paving
- Project or concept must be identified in a master plan, if applicable
- Projects must be pre-approved by Dane County Park staff
- Organization must have the capacity to manage and implement the project on their own
- Only one (1) grant application can be submitted per organization/park property per year.
- Previously awarded Friends Capital Improvement Grants must be closed before another application is accepted.

Examples of eligible projects include, but are not limited to:

- Trail construction
- Habitat restoration and perennial plantings
- Signage (interpretive, kiosk panels)
- Tree planting
- Food systems
- Mobile Storage structures (storage structures cannot become buildings)
- Interpretive Signage working with a professional designer (required)

Grants will NOT be awarded for the following projects:

- Buildings or other construction projects that exceed \$25,000 in total cost, which must be bid out through the County
- Projects that the organization can't manage and implement directly
- Plans or studies, brochures or printed materials
- Projects on non-Dane County Parkland
- Projects for personal/private benefit

- Salary or honorariums
- Vehicles, machinery, trailers, equipment or hand tools
- Memorial bench installation
- Acquisition of land or easements
- Other projects may be deemed ineligible upon review

# To apply for a **Capital Grant**, an entity must:

- Have a current 501c3 status
- Abide by all county rules, polices, and guidelines
- Have previously worked with Dane County Parks
- Have a project/program that will occur on Dane County Park property

# Available Funding

\$100,000 is available for the program. The standard grant amount will be up to 75% of the project costs with a maximum grant award of \$18,750 and a minimum grant award of \$2,000. Eligible expenses for projects include construction materials and contracted services.

All grants must be matched with cash. Donations of cash and grants from private foundations, state or federal grants are acceptable match. In-kind services are NOT accepted as match, such as donated labor, materials, supplies or discounts from vendors.

#### **Mini Grant**

Grants will be awarded for projects or programs on county parkland. Projects meet the following minimum eligibility requirements to be considered for funding:

- Total grant request for projects/ programs must be between \$250-\$2,000
- Projects must be pre-approved by Dane County Park staff
- Organization must have the capacity to manage and implement the project/program on their own
- Only one (1) grant application can be submitted per organization/park property per year

# Examples of eligible projects include, but are not limited to:

- Programming supplies, transportation, materials, gear
- Interpretive Signage working with a professional designer (required)
- Friends Group specific brochure creation, design or printing (about the friends brochure, not a park map/park brochure)
- Tools and equipment

# Grants will NOT be awarded for the following projects:

- Park Map/Park Brochure design, creation or printing
- Projects on non-Dane County Park land
- Projects for personal/private benefit
- Salary or honorariums
- Memorial bench installation
- Projects for private use or benefit
- Acquisition of land or easements
- Other projects may be deemed ineligible upon review

To apply for a **Mini Grant**, an entity must:

- Abide by all county rules, polices, and guidelines
- Have previously worked with Dane County Parks
- Have a project/program that will occur on Dane County Park property
- 501c3 status is NOT required

### **Available Funding**

\$6,000 is available for the program. The standard grant amount will be up to 100% of the requested amount with a maximum grant award of \$2,000 and a minimum grant award of \$250.

There is no match required for this grant. This grant may be used as partial funding for an activity or project that fits the criteria.

# Foundation for Dane County Parks Support & Collaborative Grant Program Discussion

Dane County Parks received nine (9) applications that met the mini grant program guidelines, for a total request of just under \$12,000, which was almost double the amount of funding available. The Foundation for Dane County Parks board of directors recently voted to make up the funding deficit, thus bringing each grant award amount up to the total amount requested from each organization.

This partnership opens up an opportunity to have a broader conversation about a collaborative grant program between the Foundation and Parks. The merging all of these grant programs is a conversation that the Land and Water Resources Department has been having for almost two years. The Foundation was a part of those early conversations and declined to join. Last year's grant cycle, in January of 2022, the Environmental Council and Dane County Parks jointly opened applications for a collaborative grant program. So when the Environmental Council grant funding was transferred to Parks, we set-up the grant program so that it very closely aligned to the Foundation's grant program, to help ease a hopefully future transition. The Foundation for Dane County Parks' Allocation Committee will review a proposal from Dane County Parks re: this possible collaborative grant program again this year.
