LEASE WITH TOWN OF MIDDLETON FOR DANE COUNTY SHERIFF WEST PRECINCT					

Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Sheriff's Office has been operating a precinct station in the 3,500 square foot lower level of the Town of Mi ddleton Town Hall at 7555 West Old Sauk Road since 1997. The current lease expired on March 31, 2023 and the Town has agreed to enter into a new 15 year lease with the County.

Current Policy or Practice -

Current annual least and fixed costs are \$23,900 for 3,500 square feet of rental space for the West Precinct. The initial annual rent of the new lease shall be \$31,500, paid quarterly, increase by 1.5% annually through the term of the lease. The lease includes options to renew for two (2) additional terms of five (5) years at a 3% increase at the initial renewal term and 1.5% for each year of the term. The County shall also reimburse 50% of the annual operation and maintenance costs of the septic system to the Town, \$2,500.00 annually for snow removal services, and \$2,000.00 for a "sinking fund" for repairs and renovations to the space. The County shall be responsible for all its utilities.

Impact of Adopting Proposal -

Entering into a new 15-year least agreement for the West Precinct will increase the annual least and fixed cost amount from \$23,900 to \$36,000.
