CC&N will provide a certified 800 MHz & VHF Emergency Responder Radio Coverage System design, material, equipment, labor, AHJ reports and AHJ compliance testing for the Dane County Jail building addition located at 115 W. Doty Street, Madison, 53703. The solution proposed by CC&N in this document is for new installation of a duplex system covering VHF MHz and 800 MHz in a single deployment.
